WHAT DOES PREMIA MORTGAGE, LLC, DBA PREMIA RELOCATION MORTGAGE (NMLS # 458540) DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. How?	All financial companies need to share customers' personal information to run their everyday business. How does Premia Mortgage, LLC DBA Premia Relocation Mortgage (NMLS #458540) collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> ▪ apply for a loan, or give us your income information ▪ provide account information, or show your driver's license ▪ provide employment information We also collect your personal information from others, such as credit bureaus, affiliates, or other financial companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> ▪ sharing for affiliates' everyday business purposes - information about your creditworthiness ▪ affiliates from using your information to market to you ▪ sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account - unless you tell us otherwise.

Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ▪ PREMIA MORTGAGE, LLC, DBA PREMIA RELOCATION MORTGAGE (NMLS # 458540) does not share with nonaffiliates to market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> ▪ PREMIA MORTGAGE, LLC, DBA PREMIA RELOCATION MORTGAGE (NMLS # 458540) does not jointly market
